

## Komunikat nr 36/2015 dla świadczeniodawców

### podstawowej opieki zdrowotnej

#### w sprawie przekazywania całościowych eksportów deklaracji za marzec 2015 r.

Śląski Oddział Wojewódzki NFZ przypomina, że zgodnie z §17 Rozporządzenia Ministra Zdrowia z dnia 6 maja 2008 r. w sprawie ogólnych warunków umów o udzielanie świadczeń opieki zdrowotnej świadczeniodawca przekazuje informacje o posiadanych deklaracjach wyboru (eksport w formacie xml wersja 5.1.6) do właściwego wojewódzkiego oddziału Funduszu **do 7 dnia danego miesiąca** w celu weryfikacji.
